From 6 April 2020, it is important that you comply with the new IR35 legislation. These new rules will shift the responsibility of assessing tax and national insurance obligations from the off-payroll workers, such as contractors, homeworkers and consultants, to the end user client and require the organisation paying the contractor's limited company to deduct income tax and National Insurance contributions (NICs). If two or more of the following criteria are met, the rules will apply to you – an annual turnover of more than £10.2 million, a balance sheet total of more than £5.1 million or having more than 50 employees. Take an in-depth look at this legislation, why it is being implemented, and how the changes will affect your business.

Best practice guidance from IR35 experts will be provided on how to assess the IR35 status of your off-payroll workers and what information is needed to complete the required Status Determination Statements (SDS).
